Complaints are to be made aware to AGGUSA via the proper channels and will be addressed in an appropriate fashion. \_\_\_\_\_
  - All signatories are aware of the necessity to protect, respect, and observe the fundamental human rights, and will not endorse discrimination, harassment, or any other behaviors that disrespect human rights and human dignity. \_\_\_\_\_

  - If a club decides to organize an event, they must respect IFAGG and AGGUSA, as well as the general rules relating to the organization of any event. \_\_\_\_\_
  - If this club's team(s) participates in an event, the club must ensure to the best of its abilities that all affiliated persons must respect the organization requirements and regulations given by IFAGG, IFAGG rules, AGGUSA, the general rules, as well as those stated by the organizers of the event. Any misconduct that is either reported or witnessed by AGGUSA will result in investigation. \_\_\_\_\_
  - The club must ensure to the best of its abilities that all persons associated with it will keep good relations with other sport organizations and authorities on both international and national levels. Any misconduct that is either reported or witnessed by AGGUSA will result in investigation. \_\_\_\_\_
  - The club and coaches will work to ensure that all persons associated with this club will do their best to support all other AGGUSA members equally, including disclosing information regarding international competition experiences via the Competition Reports. \_\_\_\_\_

- Persons bound by this Code of Conduct shall immediately report any potential violation of this Code to the Ethics Committee of AGGUSA and the Ethics Committee of IFAGG. \_\_\_\_\_.
- The IFAGG Council and IFAGG Committee determine punishment of ethical violations, however there is possibility of suspension to violators from AGGUSA for one year. \_\_\_\_\_.
